First aid can be the crucial component to save a life or prevent further injury. As part of your emergency response program, your workplace should have first aid kits and designated first aid attendants (first aiders).

Why is it important that there are first aid attendants on site? When an injury occurs, the first aid attendant can assist the worker immediately. The first aid attendant is trained to:

- Maintain a calm demeanor and take control of the situation.
- Assess for hazards before providing first aid.
- Call 911 for assistance (if needed).
- Know where your first aid kits are located.
- Use first aid kit and appropriate PPE.
- Aid the injured worker until emergency response personnel arrive.



Things Everyone Should Know

It is important that everyone knows what to do when someone gets hurt at work:

- 1. Review company policy/procedure (emergency response plan)
 - Review the roles and expectations of staff during an iniurv.
- 2. Contact/location of first aid attendant (first aider).
 - Where is the list of first aid attendants posted?
 - Identify who you work with that has first aid training.
- 3. Location of AED and first aid kit
 - Where is the equipment located?
 - Is equipment mobile (can the kits be moved or do supplies need to be taken out individually)?
- 4. How to contact emergency responders (911)
 - What is the number for emergency responders in vour location?
 - Are cell phones, landlines, or radios available?
- 5. Location of workplace?
 - Address
 - Land Location (Quarter Section Section Township - Range - Meridian)
 - Green/blue Marker Number- Road Number- Direction

Legislation

The number of kits and people trained in first aid will depend on the size of your workplace, the type of work you do and the distance your workplace is from a medical facility.

First Aid Kits and Inspections

First Aid Kit Inspection

The employer shall inspect every first aid station regularly (at least monthly). An inspection should include the following:

- First aid kits are kept in high-visibility locations.
- The locations signs are clearly marked.
- The area is free of debris and obstructions.
- Check the exterior of the kit for signs of damage.
- Locate the inventory list to determine if anything is missing from the first aid kit.
- Look for the expiration date on individual materials.
- If any materials are damaged, expired or missing ensure they are properly disposed of and replaced.

- Hazard Identification and Risk Control: Recognizing what could injure workers on the job is the first step to ensuring that they stay safe. A proactive approach to the mitigation of workplace hazards greatly increases the chance of less severe and lower rates of injury.
